AUSTRALIA WHOLESALE TOURS TERMS AND CONDITIONS 1 APRIL 2011 – 31 MARCH 2012

1) RATES

Pricing represents net wholesale rates stated in Australian Dollars (A\$), available at participating locations in the Metropolitan (including Tasmania) and Remote regions.

RATES INCLUDE:

- For specific rate inclusions please refer to online tariff

RATES EXCLUDE:

- For specific rate exclusions please refer to online tariff

2) DRIVING REGULATIONS

Minimum rental age: 21 years for car class **A, B, C, S, S1, S2, D, E, E1, P, T, V and R**
25 years for car class **M**
Tasmania requires a min age of 21 years for all vehicle categories.

Provisional licenses held for a period of at least 12 months are accepted.

Minimum age restrictions apply.

Restricted licenses are not accepted.

Provisional licenses are not accepted in Tasmania.

Young driver surcharge: Drivers from 21 to 24 years will be required to pay a surcharge of A\$30.25 per day (inc GST).
Maximum fee A\$211.75 per rental (inc GST)

Maximum rental age: There is no set maximum driving age, however, a medical certificate is recommended from drivers over 75. Ultimately it is the location's decision if they will rent to a driver over the age of 75.

ORIGINAL DRIVER'S LICENCE

Renters must present a valid driver's licence that has been held for at least one year. A foreign driver's licence issued in a language other than English must be accompanied by a certified English translation of the licence or a current International Drivers Permit. Both the International Drivers Permit and the driver's national driver's licence must be presented at the time of rental.

ADDITIONAL AUTHORISED DRIVER

Additional Drivers are free of charge. Minimum rental age and other requirements (including young driver surcharge) will be the same as for the renter. Additional authorised drivers must be registered on an Additional Driver Application. The Application forms part of the Rental Agreement.

3) DEPOSITS

All rentals are subject to a deposit to cover additional costs such as Optional Renter Protection Services and fuel. Hertz accepts all major credit cards (Hertz Charge Cards are not accepted). Third party credit cards are not accepted. The credit card presented must be in the name of the authorised renter. If the authorised renter does not hold a card acceptable to Hertz, please refer to the CASH DEPOSIT clause.

CASH DEPOSITS

Authorised renters presenting an Inclusive Tour Voucher (ITV) and no credit card will be required to leave a minimum deposit of A\$400 cash (A\$ Travellers Cheques acceptable). Cash deposits are only acceptable on car classes B, C, S, S1, D and E.

Cash Deposits are not accepted at the Broome and Kununurra locations.

We welcome cash payments upon completion of the rental irrespective of whether a credit card has been submitted for the deposit at the beginning the rental.

4) RENTAL PERIOD

One rental day consists of 24 consecutive hours.

EXTENSION OF RENTAL

Should a customer wish to extend the prepaid rental period reserved, additional days will be charged, direct to the customer, at the local Hertz "Extra Days" rate.

LATE RETURN

Hertz offers a grace period of 29 minutes on the last day, after which late return charges will apply as follows:

30+ minutes late one full day of the "Extra Days" rate will apply.

For any additional options, i.e. AER etc, purchased at the commencement of rental, the full cost will be due for each full or partial extra rental day.

UPGRADE

Voluntary upgrades as purchased at time of rental will be charged, direct to the customer, at the locally applicable upgrade rate. All upgrades are subject to availability.

5) DRIVING RESTRICTIONS

Damage Cover (DC) is invalid under the following circumstances:

- Tasmania - Vehicles cannot be driven or taken into or out of Tasmania via Ferry.
- Tasmania - **Unsealed Roads:** Vehicles may be driven on unsealed roads however, regardless of fault, the renter's liability up to a maximum of \$9900 will apply for any damage or loss sustained on an unsealed road.
- **Overhead Damage:** Regardless of fault, the renter will be liable up to a maximum of \$9900 whether the overhead damage is incurred on sealed or unsealed roads, even if the sealed road liability has been reduced to '0'.
- Vehicles may be taken onto Bruny Island however FULL RESPONSIBILITY will apply in this area.
- Alpine Resorts - Vehicles may not be driven above the snow line without the purchase of "SNO" Option. See section 7.4, Accident Damages, for details.
- Unsealed roads - **2WD and AWD vehicles** cannot drive on unsealed roads, except roads under repair and direct access roads to National Parks, State Parks or holiday accommodation (excluding Kangaroo Island where cars cannot be driven on unsealed roads at all). **4WD vehicles** may be taken on unsealed roads, but can only be driven on recognised roads or tracks. Off road driving is not permitted.
- Beach/Salt Water - Vehicles cannot be taken on any beach or be taken into or exposed to salt. Vehicles may not be taken to Fraser Island.
- Northern Territory - Vehicles are not permitted to be driven into Jim Jim Falls or Twin Falls.
- Class V, E (AWD only) vehicles may be driven on the Mereenie Loop Road. This area is the customer's 'FULL RESPONSIBILITY' for damage or loss. Any damage to the Hertz vehicles including and not limited to towing fees will be charged to customers.
- Western Australia - Only Class R vehicles may be driven on the Gibb River Road, the Tunnel Creek Road, the Windjana Gorge Road, the Cape Leveque Road or to the Bungle Bungles. These areas are the 'FULL RESPONSIBILITY' for any damage incurred. Any damage to the Hertz vehicles including and not limited to towing fees will be charged to customers.
- South Australia - No vehicle may be driven north from the Oodnadatta Track. This includes the following areas: Dalhousie Springs, Mount Dare, Witjira National Park, Pedirka Desert
- Kangaroo Island - Both 2WD and 4WD vehicles may be taken to Kangaroo Island.
- Hertz standard terms and conditions apply if a vehicle is damaged on the ferry.
- One way rentals are not available to/from the Island.
- 2wd vehicles are not to be driven on unsealed roads on Kangaroo Island. This policy is strictly enforced. Failure to comply will result with the renter accepting full responsibility for all damages.
- Dusk to Dawn Driving - Night driving is not allowed in any region designated as remote (Northern Territory, Kimberley, Exmouth, Kangaroo Island). This is a road safety issue. If an accident occurs between dusk and dawn the renter is responsible for all damage irrespective of the circumstances.
- Trains - Hertz vehicles may be taken on trains.

6) ONE WAY RENTALS

All One Way Fees are collected at the Hertz Location at time of rental and cannot be prepaid.

- Class M vehicles are available for one way hire between the locations as specified under Section 9 "Participating Locations/Availability". There is a minimum 7 days rental required and a one way fee of \$990 (inc GST) will apply.
- One ways originating from Kununurra are restricted to rentals to Broome/Perth/Darwin only
- One ways originating from Broome are restricted to rentals to Kununurra/Perth/Darwin only
- Please check Section 9 for vehicle availability at selected locations.

7) ACCIDENT DAMAGES

Hertz Australia rates include Damage Cover (subject to compliance with the standard rental terms and conditions), for the Hertz vehicle and/or Third Party Property. However an Accident Damages Excess (ADE) applies per incident regardless of fault. This is the amount the renter contributes towards the loss of, or damage caused to, the Hertz vehicle and/or Third Party Property.

ADE can be reduced with the purchase of Optional Renter Protection Services (see below).

Single Vehicle Accident (SVA) means any incident in which the vehicle is involved, which does not involve the Hertz vehicle colliding with another moving vehicle, including but not limited to rollovers, collisions with animals, and reversing into stationery objects.

Damage caused by total or partial immersion in water including crossing a waterway is considered full responsibility of the renter.

Water Damage other than total or partial immersion in water is limited to the amount of the ADE plus an excess of \$2200. The total payable on 2WD vehicles is \$5500 and the total payable on 4WD vehicles is \$8800.

Hertz offers a range of optional Renter Protection Services as detailed below.

• **AER (Accident Excess Reduction):**

- Available at all corporate and licensee locations.
- Reduces Accident Damages Excess (ADE)
- Single Vehicle Accident (SVA) is applicable at remote locations and is not reduced by AER.
- Includes Tyre and Windscreen cover on 2wd vehicles
- Tyre cover is not included on 4wd vehicles at all participating locations
- Tyres and Windscreens are not covered at Broome and Kununurra

• **MAX cover:**

- MAX Cover can be purchased at the rental counter
- MAX is void if the vehicle is immersed in water, or if overhead or under body damage occurs to the vehicle.
- Reduces the ADE to zero and reduces SVA to zero
- Available at participating locations only. Refer to Section 9 – ‘Participating Locations/Availability’ for details
- Includes Tyre and Windscreen Cover on 2WD cars only
- Includes Windscreen Cover on 4WD/AWD only
- MAX is capped at 10 days per 30 day rental period
- MAX Cover is not available at Broome and Kununurra
- MAX Cover is void if there is damage sustained to the Hertz vehicle on the Mereenie Loop Road, Gibb River Road, The Tunnel Creek Road, The Windjana Gorge Road, The Cape Leveque Road or roads to/from or within the Bungle Bungles area.

All amounts are inclusive of GST and may be subject to Location Fee (LF) and Admin Recovery (AR) charges.

- Driving a Hertz vehicle in any Alpine Resort during the gazetted snow season or any area under conditions where a reasonable person would use snow chains is "Full Responsibility Use" under Hertz Terms and Conditions. In other words, in the event of damage to the vehicle, there is no cap or limit to the renter's liability to Hertz. **SNO cover** reinstates the ADE and is available at \$22.00 per day. Vehicles for this option are restricted to Classes D/E and F.

Other Information

- The renter agrees to and accepts **full responsibility** for any of the following:
 - any damage arising from a collision with an animal whilst the vehicle is being driven between the hours of sunset and sunrise in the Northern Territory, the Kimberley region (including Broome and Kununurra).
 - **All Locations:**
 - damage caused by negligence of the driver or any of the passengers of the vehicle (including damage caused by total or partial immersion in water, including crossing a waterway)
 - damage caused by negligence of the driver or any of the passengers of the vehicle resulting in under body and over head damage to the vehicle
 - any damage caused by an action which resulted in a criminal charge being laid
 - any damage caused to the body of the vehicle by sitting on the roof or climbing on the vehicle
- All Renter Protection Services are subject to the renter complying with Hertz' standard rental terms and conditions.
- All Pricing and Rates are subject to change with 30 days written notice.

8) THIRD PARTY PROPERTY AND INJURY INSURANCE COVER

Third Party Property Liability Insurance is automatically covered under a third party property damage Master Policy executed by Hertz and is subject to the renter complying with all Terms and Conditions of the rental and payment of the Accident Damages Excess. Third Party Liability cover for personal injury is governed by separate Government legislation in each Australian State and Territory. The right to claim may be limited by the legislation and excesses may apply.

There are many factors relevant to a determination of which third party liability cover for personal injury will apply in the event of an accident, such as the state or territory in which a vehicle is registered, the state or territory in which the accident occurs and the state or territory in which another driver or injured person resides. Should an accident in which a person is injured occur, the renter must contact the police and Hertz.

This summary of the cover available throughout Australia is meant as a guide only and no warranty of accuracy or reliability is given or responsibility accepted by Hertz for the information contained below. In the event of an accident, the renter should make independent enquiries of the relevant insurer of the vehicle.

- Queensland:** Injured person or the dependents of a deceased person can bring claim for damages against a negligent party.
- New South Wales:** Compensation is available for persons injured or killed by the negligence of a motor vehicle driver. At fault drivers are not covered
- Western Australia:** Damages may be claimed by persons injured or by the relatives of a person killed by the negligence of a motor vehicle driver.
- South Australia:** Damages may be claimed by persons injured or by the relatives of a person killed by the negligence of a motor vehicle driver.
- Victoria:** Combination of no fault and negligence indemnity. Statutory benefits in the nature of weekly payments during incapacity for work, impairment benefit annuities, medical and like expenses and death benefits may be available regardless of the question of fault. In addition, damages may be claimed by persons seriously injured or killed by the negligence of a motor vehicle driver.
- Tasmania:** Combination of no fault and negligence indemnity. No fault medical benefits, death benefits, disability benefits and disability allowances may be claimable. Injured persons or dependents of deceased persons can also bring claims for damages against negligent parties.
- Northern Territory:** Claims for damages may be brought by persons injured by the negligence of a motor vehicle driver or by the dependents of a deceased person. Entitlement to no fault statutory benefits restricted to residents of Northern Territory. Non residents may apply to the Board of the Territory Insurance Office to be treated as a resident.
- Australian Capital Territory:** Injured persons or the dependents of deceased persons can bring claim for damages against a negligent party.

As specific compensation amounts vary so widely depending on the circumstances of individual claims they cannot be quoted.
